



Iowa Soccer Club 2007-08 Player/Parent Financial Contract

This contract must be filled out for each individual player.

If your son/daughter accepts a roster position on an ISC team for the 2007-2008 soccer year, this contract will go into effect on August 1, 2007. Please initial and sign if you are willing to abide by these rules. Your son/daughter will not be issued a player card until this contract is signed and returned to the ISC office.

The coaching fees are the following for each age group:

U8 players = \$25/mo (\$300/yr)
U9-U12 players = \$40/mo (\$480/yr)
U13-U15 players = \$42/mo (\$504/yr)
U16-U18 players = \$45/mo (\$540/yr)

I understand that my financial obligation to the Iowa Soccer Club for these coaching fees is a 12-month commitment beginning August 1, 2007 and ending July 31, 2008. If joining after August 1, 2007, my financial obligation begins from the date of registration through July 31, 2008. If I am approved for a scholarship, these coaching fees will be paid to the club from the Scholarship Fund.

I understand that I am responsible for either paying the entire coaching fee to the ISC office or filling out an auto-withdrawal form so that the monthly fee can be deducted from my checking account for the 12 month period. This fee is due 5 days after reserving a roster position (either June 28 for U8-U13 or July 3 for U14-U18) or on the date I join the club. Coaching fees have to be paid in full or auto-withdrawal set up before an ISA player card will be issued.

I understand that by accepting a roster spot, I am also obligated to pay a registration fee. The 07-08 annual registration fee of \$75 is due 5 days after reserving a roster position (either June 28 for U8-U13 or July 3 for U14-U18) or at the time of joining. The registration is paid directly to the ISC office

I understand that by accepting a roster spot, I am also obligated to pay a facility fee. For U8 players, the 07-08 fee is \$70. For U9-U15 players, the 07-08 facility fee is \$200. For U16-U18 players, the 07-08 facility fee is \$230. This annual fee is due October 1, 2007. Those players who join after January 31, 2008 will be responsible for paying ½ of the facility fee. The facility fee is paid directly to the ISC office.

I understand that by accepting a roster spot, I am also responsible for paying team fees, which are paid directly to my team's treasurer that cover league fees, tournament registrations, etc.
